Leadership and the Road Ahead

The profound need of individuals, families and communities for support from organizations like Devereux has never been greater – and our organization continues to respond in an ever more innovative, compassionate and evidence-based fashion. Devereux's programs and services now reach more people, in more specialized ways, than at any time in our history. We continue to expand and improve the traditional behavioral health work we've conducted for more than a century, while taking on new and extraordinarily complex societal problems, like caring for children who have been commercially sexually trafficked in our country.



It is in Devereux's DNA not only to provide the very best direct services in specific moments of need, but also to always scan the horizon for emerging problems that will require solutions informed by the latest learning in the fields of medicine, education and social science. Over the last decade, and across the next several, some of the most important developments in our field have and will emerge from the neuroscience discipline. Our understanding of the complex workings of the human brain is rapidly expanding, and it is very exciting to consider the possibilities for improved treatment interventions and prevention strategies that will develop in behavioral healthcare as a result.

The Challenge Before Us

Behavioral health challenges and intellectual and developmental disabilities (IDDs) are wide-spread among all populations. They pay little heed to economic status, gender, age or ethnicity. In 2013, there were an estimated 43.8 million adults aged 18 or older in the U.S. with a mental health illness. This number represented 18.5 percent of all U.S. adults. Even more startling is that number does not cover persons who, for the entire year, were homeless, on active military duty, or resided in correctional facilities, nursing homes, institutions, or long-term hospitals. For children and adolescents, the percentage is even higher. Just over 20 percent of children, either currently or at some point during their young life, will face a mental health challenge.

The number of individuals living with developmental disabilities is equally alarming. Researchers from the Centers for Disease Control and Prevention (CDC) conducted a study showing developmental disabilities are commonplace in the U.S. (about one in six children will be born with one or more) and that the number of such children increased 17.1 percent (about 1.8 million more children) over the 12 years studied. One of the most startling medical findings of the last decade must be the announcement that one in 68 children will live with autism.

Complicating the matter, research also shows individuals with intellectual and developmental disabilities are more likely to be at a significantly higher risk of developing a serious mental illness like depression.

Given these statistics, many of us are very likely to have a friend, colleague, or loved one fighting a daily battle for health, happiness and fulfillment against what can be staggering challenges, or perhaps the person we know waging this war is ourselves. For everyone in this position – and for everyone, for whom good overall social and emotional health must be an absolute priority of total wellness, it is imperative that mental health disorders and intellectual and developmental disabilities receive the same priority treatment – including in funding, research, diagnostic and treatment innovation, and general public understanding – as physical illness. The time has come for the challenges presented by psychiatric and behavioral disorders and intellectual and developmental disorders to be viewed within the same context of physical health.

Unlocking Human Potential - Developments in Brain Science

The key to parity for these disorders is a better understanding of where they originate and live – the human brain. Increasingly, science is making clear that just as respiratory problems are generally illnesses of the lungs and their supporting systems, mental illness and IDDs are generally disorders of the brain. We are far from a complete understanding of our most complex of organs, but advances in brain research are happening so rapidly that some scientists have likened our progress in brain science to the almost unbelievable and rapid advancements made in computer science over the last 40 years. Imagine telling an average working man or woman in 1970 that, within their lifetime, they would have computers in their homes that exceed the power and sophistication of those in the most advanced organizations of that time.

Every day, scientists are uncovering more of the secrets of how the brain develops, grows and changes, both pre- and post-natally, and how brain function and healthy development can be interrupted from what is typical and desired, especially by the experience of trauma. We now know the brain grows and evolves substantively until a person is in his or her mid-20s, and new experiences and knowledge continue to trigger ongoing brain growth across our lifespan. We also understand far more about how genes and the environment impact brain health and functioning. There is no answer to the nature vs. nurture question; it is, in fact, both components that affect brain health, and these factors will have a delicate interplay that begins before we are born and continues throughout our entire life. At Devereux, these findings about the brain and behavior and ability have practical applications for prevention, diagnosis and treatment.

Devereux's unique, system-wide, multi-level Philosophy of Care incorporates ongoing discoveries about the brain into all aspects of our services. Led by Marilyn Benoit MD, Chief Clinical and Medical Officer, Devereux is focused on both the science and the art of behavioral healthcare service provision. "What we learn about the brain, and its development, will enhance and focus diagnosis, treatment and prevention within behavioral healthcare – and also aid and inform parenting, teaching and community," says Dr. Benoit.

Take, for example, the case of the adolescent brain. While many people, particularly parents of tweens and teens, intuitively understand that the adolescent brain works differently than

that of even a young adult just a few years their senior, for most of modern medicine, adolescent brains were treated like "little adults." Medications developed, tested and approved for adults were given in smaller doses. Interventions developed for mature thinkers, were applied similarly to adolescents. Recent advances in science have informed us that, in many cases, this is not best practice, and that adolescents require unique interventions, designed specifically for their particular stages of development. This knowledge



can improve the way young people are taught, parented, treated and understood. Devereux is providing tailored strategies and best practices guidance to improve parent, caretaker, teacher, clinician and classroom approaches.

New research is also helping us to understand the many impacts that environmental stressors have on the developing brain. Recent studies reveal that trauma like abuse, neglect and abandonment in childhood affect the physical workings of the brain, and can create lifelong social, emotional and physical complications. Children who have been traumatized require specially-designed trauma-informed care interventions for true healing. From Devereux's perspective, this understanding of the impact of trauma on children is one of the most significant developments of our generation.


Another exciting area of study looks into the hierarchical development of the brain and how our early experiences affect our ability to self-regulate, which many scientists describe as one of the most important capacities human beings can develop. Self-regulation is a necessary skill for emotional well-being and academic and professional success. Proficiency in the regulation of emotional responsiveness is a critical aspect of early development. Studies have demonstrated the role of early caregiving and reducing stress. Early life stressors may disrupt the development and organization of the brain which may have long-term effects. Infants move from a crucial dependence upon the support of their caregivers to the development of more self-sufficient skills for emotional regulation around school age. Devereux's Center for Resilient Children (DCRC) promotes social and emotional development including self-regulation, and fosters resilience and skills for school and life success in children, birth through school-age.

Through the growing understanding of our complex human brains, we can develop more advanced behavioral health treatment interventions for individuals across the lifespan, and

perhaps even more importantly, serve as the tip of the spear in prevention and public education campaigns designed to help all people lead the healthiest, most fulfilling lives possible.






